General Release and Indemnification Agreement COVID-19 Policy and Release

Permission & Release: Participant has requested the opportunity to participate in the “Girl Power” Day Camp Career Exploration Event (the “Event”) to be located in Palmyra, Virginia, taking place on **November 3, 2023**. VMDAEC grants such opportunity pursuant to this Agreement. Participant’s parents or guardians give permission for Participant to participate in the Event. Participant’s parents or guardians, in consideration for being permitted to participate in the Event, do for him/herself, my spouse, my child, and my heirs, legal representatives and assigns, hereby release and forever discharge the VA, MD & DE Association of Electric Cooperatives (hereinafter the “Association”) and its members, and their officers, directors, shareholders, employees, agents, representatives, attorneys, successors, volunteers, and affiliates (hereinafter “Releasees”) from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or equity, arising from my participation in the Event, whether caused by negligence of Releasees or otherwise.

Medical Release and Authorization: Participant’s parent(s), on behalf of the child participant, further releases Releasees, officials, other participants, and any professional person of any claim whatsoever on account of first aid or medical treatment or services rendered in the course of the Event. In the event that Participant is unable to consent to emergency medical treatment, the Participant and his/her parent(s)/guardian(s) authorizes and consents to emergency medical care to be given as the judgment of medical personnel dictate.

Assumption of Risks: Participant and participant’s parent(s)/guardian(s) acknowledge and ***understand that participation in the Event is voluntary*** and freely assume all risks that may occur as a result of participation in the Event, such as influenza, MRSA, or COVID-19 exposure or infection, bodily or personal injuries up to and including serious injury, disability or death, whether those risks are known specifically or not.

Indemnification Agreement: Participant and participant’s parent(s)/guardian(s), in consideration for being permitted to participate in one or more events in the course of the Event, agree to indemnify, defend and hold harmless the Association and other Releasees, from any loss, liability, damage or cost, including attorneys’ fees and third-party claims, that any of them may incur due to Participant’s participation in the Event for any activities in connection with or arising out of the Event, whether caused by negligence of the Releasees or otherwise.

Media Release: Participant and participant's parent(s)/guardian(s) understand and agree that photo and video recording of the Event will take place, and grant a royalty-free, exclusive, and perpetual license to the Association and its members to use said photo, video, and likeness(es) in any and all media, now known or hereafter developed.

Entire Agreement and Severability: This Release & Indemnification Agreement contains the entire agreement between the parties hereto. The terms of this agreement are contractual and not merely recitals. In the event that any part of this Release & Indemnification Agreement is deemed ineffective, all other parts of the Release & Indemnification Agreement shall remain valid and in full effect.

COVID-19 Policy & Release: Participant and parent/guardian understand that the Event will take place during the COVID-19 pandemic. The Event and Participant will comply with all government restrictions in effect wherever the Event takes place. The Participant will comply with instructions from the Event sponsors and chaperones regarding face coverings used indoors, and in other settings where face coverings are prudent or required. Participants will engage in COVID-19 self-check screenings and/or temperature checks at the discretion of sponsors/chaperones. Anyone exhibiting symptoms of upper respiratory infection, nausea, or fever, will be immediately isolated and/or sent home at the discretion of sponsors/chaperones and at the parent(s)/guardian(s) expense. By participating in the Event, Participant avers that s/he has not, within the 48 hours preceding the Event had any symptoms of COVID-19, nor has participant been exposed to or in the same household as a COVID-19 symptomatic person, nor has participant been outside the United States in the 30 days preceding the Event. Participant and parent(s)/guardian(s), being competent to consent, consent to participation in the Event, and, having been informed of the risks of COVID-19, voluntary agree to the terms and conditions set forth above, both generally and specifically related to COVID-19.
